RULES FOR ENTERING THE **XX by Mexx "Nice & Wild – New Years"** ONLINE CONTEST

Contest entries and entry process

1. Any female resident in Germany, Poland and Czech Republic over 18 years of age is eligible to participate. Any female resident in Austria, Belgium, Bulgaria, Croatia, Denmark, Finland, Hungary, Netherlands, Norway, Romania, Russia, Slovakia, Slovenia, Sweden, and Switzerland, over 16 years of age is eligible to participate.
2. Employees of the Procter & Gamble group and their family members may not participate.
3. By registering to take part in the XX by Mexx "Nice & Wild – New Years" online contest, the participant simultaneously consents to her photo being uploaded and published on the XX by Mexx perfumes Internet page and being evaluated by third parties on www.XXbyMexx-perfumes.com. By participating in the photo contest, the participant assigns to Procter & Gamble any and all rights to use her photographs as well as the rights to her own image. Procter & Gamble shall not pass the data on to third parties.
4. Entries must be the personal property of the participant to be considered. The participant confirms, by submitting her photo that she is in possession of all the copyrights and other intellectual property rights pertaining to material she has submitted. Any photo submitted which is in breach of this condition shall be deleted immediately upon knowledge of such breach.
5. Participants must provide their contact details on www.XXbyMexx-perfumes.com to register for the XX by Mexx "Nice & Wild – New Years" online contest.
6. Photos depicting content including but not limited to the following are barred from participating: advertising, pornography, immoral or unethical images, animals, collages, prominent public figures, models, cartoons, photomontages, animated images, images with superimposed Internet or e-mail addresses, images with text. All submitted content will be moderated.
7. Photo submissions are only valid when they have a maximum size of 2MB and are provided in the following formats: JPG, GIF or PNG.

Voting and ranking

8. The winners will be selected by online voting.
9. The rank of each entry is based on the number of votes the entry has received. The top ranked entries are those with higher number of votes. In case of tie, the entry that has a higher average number of votes per day since the entry was approved will win.
10. All votes shall be reviewed for irregularities and, if applicable, deleted.
11. The use of automatic voting programs or similar means of manipulating the voting, as well as paid voting activities or the formation of voting groups, will lead to exclusion from participating and judging. Even subsequent to the end of the voting period, the organizers reserve the right to review the voting practices of individual participants, with the result that such individuals may be subsequently disqualified.

Prizes

The main prize is a bundle of XX by Mexx goodies for the Nice entry ranked 1 and the Wild entry ranked 1 globally.

Daily prize: Every day during the competition, one randomly selected voter will win a XX by Mexx T-shirt, informed through a pop-up window.

On top, participants from Germany, Austria and Switzerland can obtain additional prizes as follows: Top 3 Nice and Top 3 Wild entries will win a mobile phone. Entries from 4th to 13th in both the Nice and Wild gallery will win a fragrance set.

Winners and contest dates

12. The XX by Mexx "Nice & Wild – New Years" online contest will accept photo submissions from any country; however, the final winners must have their permanent place of residence in one of the countries listed in section 1.

13. The winners consent to being filmed on video and to be taken photographs together with the prize if required by the organization and further consents to the relevant film material being used by XX by Mexx perfumes and XX by Mexx Fashion to be further published

14. The deadline for entering is 31/12/08.

15. The deadline for voting by the participants is midnight (CET) on 14/01/09.

16. Winners will be notified via email before 31/01/08.

17. The prizes cannot be paid out in cash.
